B. Reinstatement Fee - 20% of current Full Active Initiation Fee

C. Berthing

- Wet Slips -\$4.50 per linear ft per month or length of berth whichever is greater
- Designated Dry Storage - \$4.50 per linear ft per month or length of berth whichever is greater
- Small boat trailer spaces to include Vipers (boats that use a hoist)- \$600 annual (paid \$50/month)
- Ramp Launched boats on dollies (505 and similar size)- \$300 annual (paid \$50/month)
- Lasers on dollies- \$180 annual (paid \$15/month)
- Kayaks/SUPs on float- must be actively used- no charge
- Small boat racks - \$12.50 monthly

D. Beverage Lockers Annual

Large - \$45

Regular - \$24

The designated Manager will store bottles left at the bar at the end of the day's scheduled bar hours. A charge of One Dollar (\$1.00) per bottle may be made at the time that the bottle is claimed by the owner.

E. Electrical Power Annual

A. Mandatory Minimum: Unattended hookup not permitted.	Permits occasional use of electric power tools from dockside outlets.	\$18.00
B. Casual use:	Category "A" plus light bulbs, radios, battery chargers, fans and TV.	\$90.00
C. Light Use:	Categories "A" & "B" plus heat tapes for three winter months , refrigeration, and occasional portable air conditioner use.	\$175.00
D. Normal Use	Categories "A" , "B" & "C" plus occasional use of built in heat pumps. Boaters should be aboard during this use.	\$300.000
E. Heavy use:	Categories "A" , "B" & "C" plus air conditioning, heaters, stoves & heat pumps used more than on an occasional basis.	\$530.00
F. Unusual use:	Use not appropriately described above.	Rates set by HYC Board.
G. 50 Amp service:	Must use category "D" , "E" or "F"	See above
H. 100 Amp service:		\$800.00 *to be reviewed

F. Visiting Yachts

(Subject to space available and the Manager's approval)

HYC Members (per day)

The intent of this category is for short-term stays. If a member remains past thirty days refer to HYC Policy and Rules III.F.6.

- 01 April – 30 November	2 days free. \$5/day for next 8 days. Balance of 30 day period is \$10/day Visiting Yachts Electric Fees apply
- 01 December – 31 March	2 days free. Balance of 30 days is \$5/day Visiting Yachts Electric Fees apply after two days.
